Dear Parents and Carers

## RE: YEAR 7 REMOTE LEARNING

As you will be aware, from Tuesday 5<sup>th</sup> January all secondary pupils including Year 7 will work remotely from home. Please ensure you have read our Parent Remote Learning Handbook ([here](#)) in preparation to support your child with this.

On **Tuesday 5th January** all pupils will be expected to log into their tutor group Google classroom by 8.45am and are expected to complete three tasks which are detailed below:

**Task 1:** PSHE activity. This will be set by the class tutor and will include a task to be submitted/turned in via Google classroom at the end of the day. This is to ensure all pupils are confident in accessing the learning platform.

**Task 2:** As you are aware Hegarty is an online platform that the Academy subscribes to and some of your child's maths homework is set via this tool. Hegarty can be accessed via all devices including a mobile phone. On Tuesday we will expect your child to logon to Hegarty and complete any outstanding work set from before the holiday and also two MemRi tasks. Please support your child by checking before the end of the day that they have been able to access Hegarty Maths and by asking them to explain to you what a MemRi task is!

**Task 3:** Last term we were pleased to announce that our new online app for e-books and audio books is now available for all secondary pupils to use at home for free. Pupils can access over 1000 books and 100s of audio books from the app, just by clicking on the 'Overdrive' tab on the RM Unify Launchpad, which pupils use to access their school email and Google Classrooms. They can also download it onto their smart phone. Your child will be able to locate the instructions to access this app via their tutor classroom. Please encourage your child to download a book and begin reading via this platform on Tuesday. They will need to share what they have downloaded with their tutor.

From **Wednesday 6th January** all Year 7 pupils' teachers will deliver lessons live via Google Meet, including a daily registration with the tutor via Google classroom, where a register will be taken and if your child is not present, they will be marked as absent on SIMS which will be followed up by the Director of Learning. Class teachers will also be able to reward/sanction via SIMS' achievement and behaviour points as normal, therefore it is vital that your child is logged on and ready to learn so that they are able to fully access the learning their teachers will be providing.
